Higher Education Scholarship

The NSDOAF Higher Education Scholarship is available to men and women accepted in an academic program in Agriculture or related studies. The student must be committed to outstanding progress towards a degree and be enrolled as a part-time or full-time student.

Applicants must have a minimum cumulative GPA of 2.5. A written essay is required (topic will be given). A personal interview may be required. Students may reapply each year they are in school. Deadlines are August 1 and January 1.

If awarded:

Funds are paid directly to the accredited institution and not to the individual.

This scholarship may be accepted in addition to other awards. Students can be part-time or full-time through each semester/quarter.


If a scholarship is awarded, a written thank you is expected to be considered for future scholarships.

MEMBERSHIP

Membership is open to men, women and children who are lineal descendants of a farmer living within the contiguous states from July 4, 1776 through December 31, 1900.

A farmer is a person engaged in varying capacities in the agricultural industry, including but not limited to farmer, rancher, farm hand, or person who owned a farm. The fact that an ancestor has another profession or occupation does not prevent that ancestor from being a farmer where requirements are met. A census record citing the ancestor's occupation as farmer is sufficient.

Use the short form for a farmer who is documented on an approved application from another lineage society.

You may use ANY generation of that line, the NSDOAF line does not need to be the approved ancestor on the application.

Attach a copy of your approved application from NSDAR, NSSAR, etc. - all 4 pages, our short form and one proof your ancestor was a farmer. Long forms are available.
